Administrative Advisory
Committees serve to evaluate specific issues of the campus and to subsequently make recommendations to the Chancellor in regards to policy-making.

ASSOCIATED STUDENTS:
A.S. Environmental Affairs Board

The purpose of the Environmental Affairs Board is to act to preserve and enhance the natural outdoor environment at UCSB. This Board should continually act to preserve the environment of this campus community, working on campus and off campus, openly protesting or confronting those who threaten it and educating those who bring harm to it. It should act to enhance the environment as well, providing environmental perspectives throughout the University and campus community.

A.S. Student Lobby

The Student Lobby is responsible for the education of our Student Body and the surrounding community about pertinent political issues and developments, and for relaying ASUCSB opinions to the appropriate units. Further, Lobby is responsible for advocating solutions to those developments relative to students' rights, needs, and concerns.

A.S. Student Commission on Racial Equality (S.C.O.R.E.)

The A.S. Student Commission on Racial Equality is a body funded by the U.C.S.B. undergraduates concerned with providing a positive and comfortable learning environment for persons from diverse and underrepresented social backgrounds (i.e., Hispanics, Blacks, Asians, Native Americans, etc.). Its purpose is to confront and pro-actively resolve issues of ethnicity-related concerns and create and promote programs to educate the student body on issues concerning the campus and community that affect students of U.C.S.B. This Commission shall implement and support rules and regulations that will help provide a more comfortable atmosphere

for students of color on this campus, and network with other groups, campus departments or other universities to help combat racism at U.C.S.B. or other educational institutions. The Commission shall form subcommittees as deemed necessary.

ADVISORY:

Affirmative Action

To study and report to the Faculty Legislature on all matters of affirmative action including (a) academic personnel and policies affecting women and ethnic minorities: (b) access of women and ethnic minorities to graduate and undergraduate programs in all academic areas, (c) seeking information and making recommendations regarding actions necessary to remove and correct inequities of opportunity.

Disabled Students

To advise the Chancellor and other campus officials on those matters pertaining to programs, services and the setting of priorities for students with disabilities. The committee will also assist in the evaluation of current campus policies, programs and procedures relating to students with disabilities.

Student Health

Examine, evaluate and make specific recommendations to the Student Health Service Director on issues relevant to the operation of the Service. 3 undergraduate students.

ACADEMIC SENATE: Student Affairs

To meet regularly with the Vice chancellor for Student Affairs and to consult with him on matters affecting the relationship between the administration of student affairs and the academic mission and goals of the University.

Financial/Money

ASSOCIATED STUDENTS:

A.S. Business Services Committee
To act as a consulting body for the following Associated Student's Businesses and Services: A.S. Bike Shop, A.S. Cashier's, A.S. Publications, A.S. Word Processing, A.S. Notetaking, A.S. Ticket Office, A.S. Legal Services Resource Center and any new services which may be developed by the Sub-Committee. This committee will serve as a recommending body for the aforementioned groups to the Legislative Council and the A.S. Executive Director. In conjunction with the business managers, will make recommendations to Finance Board regarding the yearly budget. It will review, evaluate, and ensure compliance with business policies and contracts. It will also serve as a liaison between A.S. Business Managers, Student Employees and Legislative Council. The Committee will seek proposals for other business enterprise ventures and will serve as the recommending body to Legislative Council

all former proposals for future A.S. Business Enterprises.

A.S. Business Services committee will seek to improve the existing A.S. Business Enterprises. This may include but is not limited to seeking ways to improve sales through advertising, sales promotions, and other methods. The committee may make recommendations as to improvements in daily operations. Finally, the committee will seek, explore and develop proposals for new business enterprise ventures.

A.S. Finance Board

A.S. Finance Board is the financial arm of the A.S. Legislative Council. It is responsible for the yearly budget (annual allocation) and implementation (education and enforcement of A.S. Financial Policies and Procedures) of Associated Students monies. All motions made by Finance Board must be approved by legislative Council. Finance Board shall also be re-

sponsible for approving all Travel and Entertainment requests in accordance with Article XIX of the ASUCSB Bylaws/

A.S. Investment Advisory Committee (ASIAC)

To act as an advisory committee to the Legislative Council and the Associated Students for the investments of A.S. funds. The Legislative Council will make final policy decisions and the Executive Director will make operating decisions on all investments.

A.S. Underwrite Board

Underwrite Board is responsible for granting underwrites, "no interest loans," to eligible student groups for fundraising. The Underwrite Board shall also be responsible for requisitioning and all other administrative and follow-up duties associated with underwrites.

ADVISORY:

Student Fee Advisory Committee

Advises on activities supported by income from student registration and education fee programs and recommends priorities for funding. 2 freshmen undergraduate students (possible three year term).

Student Financial Services Advisory Committee

Advises and recommends to the Director and staff of Student Financial Services. 4 undergraduate students.

Income and Recharge Committee

Reviews and makes recommendations on rate structures and proposed changes to rates submitted by campus service units for goods and/or services. 1 undergraduate student.

Media and Information

ASSOCIATED STUDENTS: A.S. Communications Board

The A.S. Communications Board assumes sole responsibility for producing and publishing Campus Point for the purpose of outreach to the students, staff, and faculty. Campus Point shall provide coverage of news and events within the campus community and to provide relevant information on the campus and the student body through Associated Students Information Agency.

A.S. La Cumbre Excellence Committee

To find ways to improve the yearbook. The Committee must select an Editor, meet with staff periodically, and provide advice to the La Cumbre staff. Board members are expected to keep up with various national agencies, make comparisons with other collegiate yearbooks, and make their findings available to the yearbook staff and the Associated Students.

A.S. Program Board

The Associated Students Program Board is a student-funded, student-run campus organization dedicated to producing and supporting entertaining and culturally diverse events for

the UCSB campus and surrounding community. The Board also provides an opportunity for students to gain a wide range of experience in planning, production, and support committees, each headed by a student coordinator.

A.S. Radio Council

Radio Council is the governing board of KCSB. Through the General Manager, Council oversees both KCSB-FM and KJUC-FM Cable, and provides a link between the station and the Associated Students, as well as the UCSB Administration. Radio Council shall set broad policies for the station, and will notify KCSB's Executive Committee about any policy proposals at least one week in advance of the Radio Council meeting at which they are scheduled to be introduced as New Business. These policies include, but are not limited to, reviewing and setting the station's goals and purposes, descriptions, codes of conduct, and budgetary approval. Radio Council, shall select (and remove, if necessary) the General Manager of KCSB.

ADVISORY:

Arts and Lectures Committee:

Works with arts and Lectures on the development of Arts and Lectures programs. 1 undergraduate student,

Women's/Gen

ASSOCIATED STUDENTS: A.S. Women's Commission

The A.S. Women's Commission is a group funded by the UCSB undergraduates to advise Legislative Council on all aspects of campus concerns pertaining to women. The Commission also educates about and is an advocate for women's rights and feminist issues, and has a commitment to representing and improving the status of women both on campus and in the community. Five (5) umbrella committees constitute the commission: Cross Cultural, Women's Health, Rape Prevention and Education, exploitation in the Media, and Publicity.

Dispute Media

ASSOCIATED STUDENTS:

A.S. Constitution & By-Laws Committee

This Committee is responsible for recommending on all matters pertaining to the ASUCSB Legal Code. The Committee will study the code and make recommendations on needed legislation.

A.S. Elections Committee

Elections Committee coordinates the mechanics of the A.S. Elections, including the first balloting and any May runoffs, if necessary. The main function of the Committee is to run the Spring General Election, including poll set-up, computer programming and general coordination of many diverse facets of the Elections. The committee shall also coordinate any and all Special Elections in the event that any arise.

Judicial Council

The Judicial Council shall be empowered to hear and decide any case under original jurisdiction as set forth in Article V. of the A.S. Constitution. Included in this provision is the responsibility to adjudicate completely and diligently questions pertaining to The A.S. Legal Code, and render a just and equitable resolution. Accordingly, the Judicial Council may hear, under the auspices of just representation, cases on alleged violations

Community Affairs Board (CAB), is dedicated to enhancing the educational experience of all UCSB students by providing easy access to community service work. Through a diversity of projects and community outreach, CAB seeks to augment classroom experiences, to create opportunities for career exploration, to connect UCSB to the community in a meaningful way, and to promote the ethics of Public Service.

Isla Vista Community **Relations Committee**

Isla Vista Community relations Committee is responsible for the education of the campus and student communities regarding issues within Santa Barbara County and Isla Vista that have an effect on students. Such issues may include but are notlimited to: Safety, police/community relations, landlord/tenant relations, emergency and other vehicle access in Isla Vista, parking, and County and University funding for programs and services in Isla Vista.

ADVISORY:

Comprehensive Childcare Advisory Committee:

Studies childcare issues and develops recommendations for addressing the childcare needs of the campus community. 2 udergraduate students (1 with child at UCC).

Housing and Residential Services Advisory Committee

Concerns the functional and programmatic aspects of housing program to protect and maintain the quality of the housing facilities and administrative structures as originally conceived. 1 udergraduate student.

Public Safety Committee

Advise on all property and personal safety issues, including, but not limited to, bicycle/pedestrian safety, major events and environment and capital planning; analyze and recommend solutions to safety issues. 3 undergraduate members (1 A.S. Leg Council Member, 1 undergraduate student, one I.V.

Science

ADVISORY Animal Care

To recommend procedures to insure compliance with animal care laws as they apply to campus use of animals for experimental and instructional purposes. Advises the Director of the vivarium on its use and operation, as required.

Biosafety Committee

Assists the Environmental Health and Safety area in developing guidelines for safe use of biohazards. 1 undergraduate

Chemical Safety Committee

Provide advice on the safe use and appropriate disposal of chemicals on campus, chemical safety policies, strategies for implementing regulatory requirements, the development of the most cost effective and efficient ways to accomplish all of the above, and rates and recharges for chemical disposal; chemical program. 1 undergraduate student.

Material Research Laboratory **Building Planning**

To oversee the development of the new Materials Research Laboratory and advise as necessary. Currently, the Detailed Project Program (DPP) phase is underway; the DPP phase is **Natural Reserve System Committee**

The Academic Affairs Board's purpose is to increase the quality of undergraduate education at the University. AAB provides services that help students find and define their educational goals, and also tries to increase the contact between students, faculty, and the Administration.

ADVISORY:

Counseling and Career Services Advisory Committee

Provides advice on policies and programs pertaining to Counseling and Career Services. 3 undergraduate students.

Human Subjects Committee

Program Review Committee

Participates in the periodic external site reviews of undergraduate and graduate academic programs and departments. 1 undergraduate student.

Student/Faculty Conduct Committee

Recommends disciplinary action in response to inappropriate student conduct in academics, and in all other areas, with the exception of the Residence Halls. Also reviews readmission requests. Advises on organizational discipline and regulation interpretation. 3 undergraduate students (possible

School and College **Outreach and Visitation**

Provides advice and recommendations to the Director of Admissions and the Director of Relations regarding the school and college visit plan. Provides a formal and regular channel of communication between the Office of Relations with Schools and its many publics, including the students, faculty, staff and administration of the University. Advises and makes recommendations on policy and procedural issues affecting the school and college visit plan, including: criteria for selecting schools and colleges for visits; prioritizing the schools and colleges selected for visits; evaluation techniques to determine effectiveness of visits; review of school visit

Executive Board for College of Letters & Science The Executive Committee of the College of Letters and Sci-

ences invites the Associated Students to submit the names of two to three nominees for consideration for appointment as student representative to the Committee. Nominees should have a GPA of at least 3.2 and it would be desirable if they would be able to serve for a period of two years.

ACADEMIC SENATE:

Academic Freedom

To study and report to the Faculty Legislature concerning any condition which may affect the academic freedom of the University, especially with regard to: acceptance of university appointments, resignations from such appointments, and to the reputation of the university and individual members of its

Admissions and Enrollment

To consider and report to the Faculty Legislature and to the Chancellor on matters involving admissions, enrollment, and redirection at Santa Barbara.

Education Abroad Program

This committee represents the Santa Barbara Division in all matters concerned with the Education Abroad Program.

Educational Policy and Academic Planning (CEPAP)

To formulate and recommend on educational policy as its primary responsibility in all matters of Divisional concern. To establish, from within its membership, a Planning and Budget Subcommittee, whose responsibilities shall be: (a) to formulate for adoption by the whole committee on behalf of the Santa Barbara Division recommendations to the Chancellor regarding the long range educational plan of the campus and the university, and (b) to formulate for adoption by the whole committee on behalf of the Santa Barbara Division recommendations to the Chancellor regarding the university budget for the Santa Barbara campus.

Effective Teaching and Instructional Support

To promote good teaching, to propose programs that will foster it, and to develop criteria for its evaluation. To formulate and recommend to the Chancellor general policies concerning instructional support activities of the Santa Barbara campus. To advise the Chancellor, the Dean of Instructional Development, and the Santa Barbara Division regarding campus budgetary needs for support of instruction.

Academics and Curriculum (Continued)

Extended Learning

To advise the Chancellor on any matters concerning the functions and the educational and related budgetary and personnel policies of University Extension and of Off Campus Studies. To report to the Faculty Legislature on matters affecting University Extension and Off Campus Studies. To advise appropriate offers with respect to (a) University extension courses yielding credit, (b) admission requirements for such courses, (c) establishment and discontinuance of Extension programs, and (d)criteria for appointment and retention of Extension teaching staff within the jurisdiction of the Santa Barbara Division. To present to the Executive Committee of the college or school concern, and to the Graduate Council, recommendations regarding part-time and non-traditional students.

Faculty Welfare

This committee advises the Faculty Legislature on mat-

ters concerned with the economic welfare of the faculty, such as salaries, benefits, insurance, retirement, housing, and other matters that affect the conditions of employment.

General Education

To study every aspect of the general education program at Santa Barbara and make comparisons with similar programs in other institutions, consider recommendations from members and committees of the Division, and in general seek to provide a common cultural experience for all students. To determine standards governing the general education requirements for the degree of Bachelor of Arts and Bachelor of Science, and specify the means of satisfying these requirements, subject to ratification by the faculty Legislature. Includes a subcommittee on American History and Institutions with representatives from the

History and Political Sciences departments.

Undergraduate Courses

To exercise plenary powers regarding the authorization, discontinuance, supervision, and final approval of undergraduate courses, including the power to determine the appropriateness of the assignment of an instructor to a specific course. To issue policy rulings derived from the powers authorized above.

Undergraduate Preparatory and Remedial Education

To monitor and conduct periodic reviews of preparatory and remedial education. Under the direction of the university Committee on Undergraduate Preparatory and Remedial Education, to supervise the administration of the examination in Subject A and the course in Subject A; to supervise the use of placement examinations in mathematics.

Campus Planning and Administration

ASSOCIATED STUDENTS:

A.S. Campus Development Committee

The A.S. Campus Development Committee shall be responsible for monitoring campus development as outlined in the 1990-2005 U.C. Santa Barbara Long Range Development Plan. The committee shall conduct research into the quality of life and education as they relate specifically to undergraduate and graduate students. Furthermore, this committee shall be responsible for the creation of a Student Impact Report (SIR) each quarter in order that this research may be continuously examined as development progresses. Finally, the A.S. Campus Development Committee shall maintain accurate informational files relating to campus development, update them as necessary and preserve all finalized documents of the 1990-2005 U.C. Santa Barbara Long Range Development Plan to ensure its guidelines are consistently followed.

ADVISORY:

Campus Activities Center

Provide advice and recommendations on programs and services, policies and procedures, budget and fundraising, organizational structure and planning processes. Provide a sounding board for problem areas in the Campus Activities Center's functioning and relationship with the campus community. 4 undergraduate students (1 A.A., 1 RHA, 1 fraternity/sorority rep, 1 cultural organization).

Events Center Advisory Board

Make recommendations concerning all functional and programmatic aspects of UCSB's Events Center so as to

protect and maintain the original purposes for which the facility was constructed. 2 undergraduate students.

Parking and Transportation Committee

Reviews plans, policies, operations, rates, and budgets for the UCSB transportation and parking programs. 1 undergraduate student.

Physical Planning

Advises the Chancellor on all matters related to the physical and environmental aspects of the campus, including: the design and siting of new buildings, exterior alterations and site improvements, circulation systems, pedestrian and bicycle paths, roadways and parking; review recommendations for selection of Executive Architects; long range development plans, site studies, landscaping and area studies; recommendations for selection of consulting campus architects; changes to the exterior physical elements on the campus.

Recreation Center Governance Board

Addresses policies governing the Rec Center's purpose and image, facilities, services, programs, activities, scheduling, access and establish user fees. Authority over operation and development of the Center with respect to matters involving policy and have authority for approval of Rec Cen budget. 5 undergraduate students.

UCen Building

To oversee and advise on all issues pertaining to the rebuilding and construction of the UCen.

University Center Governance Board Develops policies which affect all areas within the University Center including the budget, long range planning, operations, programs, facilities, purpose, and image. 4 undergraduate students (1 sophomore, 2 juniors, 1 senior).

ACADEMIC SENATE: Capital Projects:

Subcommittee on Capital Planning

Work with administration in reviewing the academic impact of major capital projects. Work with administration in delineating the criteria used in developing detailed plans. Review plans for particular major capital projects. Review plans to insure that the plans reflect the pre-established criteria and to review UCSB's five-year list of major capital projects.

Subcommittee on Architecture, Physical Planning and Environment

Work with the administration in the selection of profession architects, planners, and landscape architects. Work with administration to develop campus design guidelines. Review specific planning and design proposals pertaining to campus landscape and architecture; consult with facilities management respecting maintenance and alterations of campus facilities, including landscaping. Consider impacts of proposals and recommendations that may significantly affect the quality of the campus' environment.

Library

To advise the Chancellor regarding the adequacy and growth of the Library at Santa Barbara.

Other Appointed Positions

ASSOCIATED STUDENTS:

A.S. Committees Coordinator

The Committees Coordinator supervises the orientation of student representatives to Academic Senate and Administrative Advisory Committees, is responsible for gathering and distributing information to and from all representatives to the perspective A.S. Boards and Committees, and supervises the A.S. Intern Program by soliciting for interns each fall and placing as many interns as possible to aid Legislative Council representatives and Executive Officers. He or she also chairs all of the Committee on Committee meetings.

A.S. Assistant Committees Coordinator

The Assistant Committees Coordinator assists with the orientation of student representatives to Academic Senate and Administrative Advisory Committees and assists the Committees Coordinator in all of his/her duties as needed.

A.S. Controller

The A.S. Controller assists the Legislative Council with their accounts, analyzes proposed capital expenditures, advises the various Boards and Committees on the formulation of a budget, advises the Accounting Department on control of accounts, advises on overall increase in cost-effectiveness, researches projects, and handles other miscellaneous duties that the A.S. President assigns

A.S. Attorney General

The A.S. Attorney General acts as the investigator and prosecutor in ASUCSB Legal Code cases and acts as an advisor to those who bring their own cases.

A.S. Campus
Office Director

The Campus Office Director works with the External Vice-President for UCSA to coordinate system-wide activities and work actively with UCSA in Sacramento as an official Lobby representative from UCSB.

A.S. Student Advocate

The A.S. Student Advocate works with and assists the A.S. Collective Bargaining Committee, assists the A.S. Student Lobby in projects, assists the A.S. President when deemed necessary, assists any and all undergraduate students in research of issues, policies and grievances against the Associated Students, University of California at Santa Barbara and the University of California, consults with the A.S. President on issues concerning UCSB students, represents students on issues when requested, gathers, keeps and maintains information on policies, procedures, laws and practices of UCSB for students to look up and review at any time, and questions and challenges policies of the University when deemed necessary.
