## Many complaints are anti-police

In a random sampling of reports filed on the 125 arrests made Wednesday through Saturday nights, four out of five included eye witness accounts of police brutality and/or reports of the denial of legal rights for those arrested.

The most common complaints include "jabbing in the guts and groin," beatings with billy clubs, not being allowed to make two telephone calls (which is a right of anyone arrested) and general harassing by police.

According to Gerald Franklin, student defense lawyer, who has talked to many of those in jail, most of the brutality by the police was done "out in the field" at the scene of the arrest in Isla Vista.

He stated that almost everyone arrested was "pushed around." Many, for example, were tackled while running.

Although there were a few incidents of beatings in the jail, Franklin explained that generally the harassment there was "military chicken stuff" compared to what was experienced prior to being jailed.

Misconduct by police was also reported as having occurred on buses to the jail. Some of those arrested said that they had been struck or had their head pushed against the window.

One rather comprehensive report was given to EL GAUCHO by Alfredo Wolfe, a photographer who was arrested Wednesday night.

After Wolfe was arrested, he was taken to the Bank of America where he was held temporarily, and he reports that the police were "knocking me on the head on the way up there."

He and the others who were arrested were handcuffed with thick white plastic loops which cut off the circulation in their hands. The police repeatedly tightened up the cuffs, and many hands turned blue and swollen from lack of circulation. Doctors told some that their hands will be numb for two weeks.

Between 2:30 and 7 a.m., Wolfe and 34 others were held at the command post. They were forced to stand up against the wall the entire time, and if they moved or talked, they were hit or "smashed against the wall face first."

Ten police with shotguns stood guard, continually teasing and laughing at the prisoners.

One of the victims fell down in pain, crying. When asked what was wrong with him, he said his hands hurt from lack of circulation, but nothing was done for him.

Wolfe was finally released at 3:30 p.m. Thursday. During the entire time he was not given any food, and he was allowed to make only one phone call.

He said that it is not possible for the media to relate all of the violence that is being committed by the police because most of it is done "undercover" subtle ways. For example, he told how officers pinch prisoners in the arm, pull them on the wrists or quickly knock them with a club when no one is looking, especially those with cameras.

Another impression which Wolfe was given was that although some of the officers wanted to stay away from the teasing and

The streets of Isla Vista have been relatively quiet during the weekend due to occupying forces of between 300 and 500 police and National Guardsmen, pouring rain and the jailing of 125 residents on charges ranging from violation of curfew to conspiracy.

Friday night brought the first enforcement of the curfew when helicopters circled the area at 5:30 announcing that a state of "extreme emergency" had been declared. Residents were warned to stay off the streets and the majority complied. By 6:30 p.m. police outnumbered citizens walking the streets three to one.

There were a few reported incidents of attacks on police or police cars. No police were injured, but 68 residents were arrested. Most of the arrests were made during guard sweeps when loiterers were caught in between police moving from both directions.

One mass arrest was made when police ordered the approximately 30 people in Discount Record Store to leave the premises and kneel down on the ground outside. Prisoners were used as shields against rocks being hurled at police as they moved up Embarcadero del Mar toward the loop. Those who were not used as shields, were let go.

Other arrests made on Friday included random pick up of pedestrians and a few house arrests made by police without warrants who broke down doors of apartments.

Although the number of

arrests on Friday was the highest thus far, there was no reported damage done to property. The mood of those on the streets seemed to be more curious and intimidated than belligerent.

At one point about 50 people gathered in front of

police lines on Trigo and danced to the tune of an accordion. Police lines charged into the crowd.

Several people stopped to speak to National Guard troops; most found that the troops didn't like their jobs (Continued on p. 3, col. 5)

## National Guard on warning status

Commanding General Charles Ott, in charge of the National Guard forces brought to Isla Vista, explained last

Friday that Military Police had been called up from Los Angeles and a rifle battalion was summoned from Glendale.

These men gave assistance to the local National Guard 144th

Battalion, California Highway Patrol and men from the Sheriff's department.

Harold W. Sullivan, commanding the California Highway Patrol, declined to give the exact number of men called to Isla Vista, but stated that CHP came from the coastal areas and the Los Angeles region.

Ott said that the National Guard units had been on warning status since Thursday afternoon and were called to duty at 12:15 a.m. Friday morning. In addition to the elements already present in I.V., the general commented that there are other elements on alert.

"There are 12,000 National Guard in California and we have in excess of 2,500 on standby. We have enough in the area to accomplish the mission," Ott said on Friday.

Ott also declined to give exact numbers, but said that they would use whatever was (Continued on p. 3, col. 4)

# Treat for dance fans planned

# Anti-violence petition signed by 4,500

In reaction to last week's violence in Isla Vista a group of UCSB students headed by junior Harvey Levin circulated an anti-violence petition Friday.

During a period of seven hours over 200 volunteers collected a total of 4,500 signatures from students on campus and in Isla Vista.

The text of the petition

read, "We the undersigned, out of a deep concern for our society and its problems, condemn the violence which occurred in Isla Vista as a self-defeating effort to correct society's problems."

Levin, in a press conference Friday afternoon, emphasized that this petition condemned all violence including that on the part of students, police, non-students or any other agency.

"We believe that a majority of UCSB students still believe in effecting change without violence," Levin stated.

harassment, they felt forced to go along with it in front of the others. He said that the younger and lower-rank officers were usually worse on the prisoners than the others, and the field officers were worse than the jailors.

Others in jail reported that they had no blankets, mattresses, heat or toilet paper. One said they were awakened several times during the night, and two observed incidents of beating in the jail.

Similar classes were given in Berkeley. Because of the knowledge gained, several students have been able to represent themselves successfully in misdemeanor cases in the Alameda County Courts.

and would have far preferred to be at home. Cookies and coffee were brought to guardsmen who, if they got too friendly, were often sent by their commanders to the back lines.

Saturday night guardsmen used the same tactics but no arrests were reported although several were picked up and

threatened. Pouring rain and fear kept most residents off the streets. The Guard was withdrawn at about 11:30 p.m. because the streets were virtually empty.

Sunday, during the day, streets were noticeably less occupied than usual by police cars. Guardsmen have reported that they expect to be sent home on Monday.

There are still many people in jail.

necessary to provide law and order as directed by Governor Reagan.

The men are trained for this type of action—many of them were in Watts," stated Ott, who was also the commander of the National Guard during the Watts riots. "All the young men have had basic training, which is six months active duty, and they're all equipped with riot gear. The men have rifles with sheathed, fixed bayonets, chemicals, gas masks and steel helmets—full combat gear."

When asked what the orders were concerning the use of rifles, Ott replied, "The orders are to use the minimum amount of force necessary to restore order."

# The perfect prison

Perhaps the jailing of the Chicago 7 (plus one) is not so bad after all—for them. At least they are imprisoned in something concrete. At least they know they are in a prison.

If one were to construct the perfect prison it would seemingly be one that was escape-proof. A prison that the prisoners could not escape from. A prison that the prisoners would not want to escape from. A prison that was constructed in such a manner that the prisoners were unaware that they were prisoners.

If all went according to plan, the prisoners could live their lives from birth to death: marry, reproduce, engage in business activities, recreation and entertainment—provided they abided by the laws of the prison. But to hand down laws from the warden's office would upset the whole scheme; the prisoners must be made to think that they create their own laws and their own law-enforcement agencies. Therefore, each prisoner would have to go through a long period of intensive conditioning, to be brainwashed into believing that he could control his own destiny. Perhaps a system under the guise of education could be used to gain the desired results.

Those who pass through the upper echelons of conditioning could be effectively used to condition others who were unable to go through the entire brainwashing program. How amusing it would be to watch those with "higher" education telling others what to do and how to do it when they were the most gullible, the most easily duped of all.

We must not neglect the fact that there may arise members of the prison society who do not wish to adhere to the political, social and economic systems that the higher-ranking prisoners have been

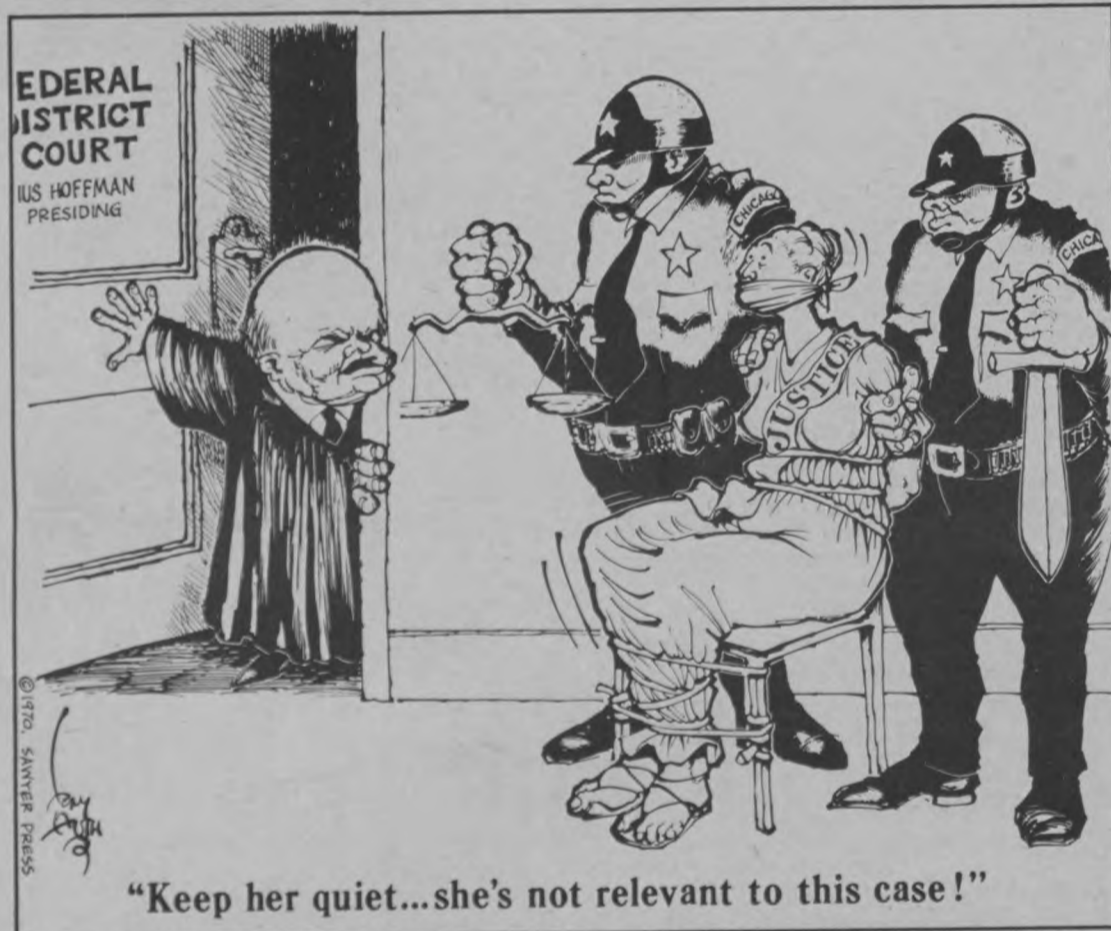
made to establish. These people would be dangerous elements, and could expose the existence of the prison. Therefore, they must be segregated into various camps throughout the prison grounds, and divested of as much "power" as possible in such a manner as not to arouse the other prisoners. These would-be escapees must not be allowed to organize effectively, lest they break down the conditioning systems that have been established and expose the prison to the other inmates.

Those who would attempt to organize resistance to the internal prison policies and the scheme to expand them internationally must be detained in visible prisons in the name of "justice" to serve as examples to other prisoners that they must maintain good prison conduct. Good prison conduct might be known as "patriotism."

But, alas, it is too late. Something in those smoke-filled rooms, where those who really run the prison meet and plan their strategies, went wrong. Somehow the wardens blew it and became too overt in their repression of the unruly prisoners. By their own actions, those backroom wardens helped the prison organizers to expose the prison to more and more people. Some "dupes" are beginning to find out how and why they are being duped. Some who are engaged in the maintenance of the "legal" system are beginning to see (and feel) the fallacy of that system.

As the wardens exercise more repression through their "dupes" down to their "stoolies," they are helping to spread the awareness that their prison exists. And now—they cannot escape. The word is out and is growing. There is going to be a mass "break" soon. Pass it on.

I was pleased the Bank of America was burned down. What institution could better symbolize the terror and oppression this country perpetrates? I ask who can even estimate the untold sufferings that are caused by our bank of American lives?

A change must take place. The "State of Emergency" powers of the President and the Governor are being used to complete the take-over of the fascist state. Peaceful change is ineffective. Racism, pollution and imperialism are permanent institutions of this society. They cannot be voted out. They will not change. The Bank of America (except Isla Vista) is open for business as usual. Burn down the Bank of America. Burn down all the banks.

There are those who sympathize but don't want us to act. They say our actions only strengthen the "right." These people are telling us to be good niggers. They are telling us not to act like free people because the police will come. This is merely the passive form of fascism—everyone has agreed to follow orders so that they do not have to go to jail or camps.

I was deeply upset by the violence that has wounded so many people. One thing, however, is clear; this government only cares about violence to property, in other words a profit loss. Violence directed toward oppressive property should be actively engaged. Violence toward people, even cops, must remain defensive. We have the right to defend our community.

No more Haymarkets. No more Hiroshimas. No more Chicagos. No more United States of America. Woodstock now.

## I.V. 'war' condemned

To the Editor:

From my point of view I can not help condemning the violence that took place in I.V. during the last few days. I have derived my way of living from the writings of Martin Luther King and Thoreau among others of non-violent persuasion....What happened in I.V. this past week amounted to a war in microcosm and I must object to it for the same reason that I object to the war in Vietnam — that violence is not a just means to any end.

It seems as though the radicals have adopted the same attitude that the establishment holds toward getting things done. This is, if someone or something stands in the way of what one wants to do, one just arbitrarily destroys them or it. The United States Government kills Vietnamese peasants because they are Pro-Viet Cong and the U.S. Government wants them to be pro-West. Likewise, radicals destroy the Bank of America because they don't like its investment policies which support the war in Vietnam. Over five years of war has not made the Vietnamese pro-Western and the violence in I.V. has only served to bring armed police into the community, adding to the oppression here.

I think that these events mentioned above amply show the futility of violence. Non-violent solutions are brought about without the destruction and death that accompany violent solutions to problems. I am in favor of certain changes that are needed on campus and in the community, but I consider it a tragedy when violence is waged, even to achieve the ends I want to see come about.

## Chancellor's 'Declaration of Campus State of Emergency'

Noon, February 27, 1970

The Isla Vista community suffered through yet another night of major disturbances in the course of which there was again serious injury to persons and property. The disruptions occurred in defiance of both a curfew imposed by the Santa Barbara County Board of Supervisors and a state of extreme emergency declared by the Governor. These acts of violence—senseless, wanton and self-defeating—constitute an intolerable threat to the safety of persons living in Isla Vista and to the security of this campus. Although Isla Vista is not an integral part of the campus, it is almost entirely surrounded by the campus and most of its population consists of students. It is, therefore, impossible to separate what has been happening there from the problem of preserving the peace of the campus and continuing its orderly operations.

I am, therefore, placing into immediate effect a state of emergency on this campus and in cooperation with the office of the Governor, the Santa Barbara County Board of Supervisors and interested law enforcement agencies, will take whatever measures are necessary within my authority to safeguard persons and property on this campus and to maintain educational activities. In accordance with this state of emergency, the following policy is placed into immediate effect on this campus:

1. Since the use or threat of physical force to coerce persons using University facilities for teaching, research, study, administration and related University activities on campus is a fundamental violation of conditions of membership in an academic community, any member of the student body, faculty, or staff found by way of the appropriate hearing process to have engaged in such misconduct shall be separated from the University, that is shall be suspended or dismissed. No exceptions may be made to this policy except upon an unequivocal showing of extraordinary, individual, mitigating circumstances. This policy applies to students, faculty and staff acting as individuals and as knowing participants in group or concerted activities, the purpose or likely result of which is to exclude other people from, or coerce them in, the use of University facilities, or is to disrupt, obstruct, coerce, or interfere with any University teaching, research, study, administration, or other University activities on campus.

2. If evidence is presented to the University that individual members of the student body, faculty or staff engaged in violent or destructive acts during the present disturbances beginning February 24, 1970, within the areas covered by the Governor's state of extreme emergency such persons will be immediately suspended pending a prompt hearing.

3. I wish to make it clear that the resolution adopted yesterday by the Santa Barbara County Board of Supervisors applies to the campus and is specifically meant also to be included within the prescriptions of the state of emergency declared for this campus. I call particular attention to numbered paragraph 2 of the resolution which specifically bans rallies and the use of voice or sound amplifying equipment.

The provisions of the campus state of emergency as noted in numbered paragraphs 1 through 3 above shall remain in effect until further notice.

I wish now to commend those members of this student body and other citizens of Isla Vista who these past few days and nights have undertaken, often at the risk of their personal safety, to prevent acts of violence by others and to work for a return to peace in our community. Certain members of the Legislative Council of the Associated Students have publically condemned these disruptions as have officers of the faculty. All these students, faculty and citizens merit the thanks of every citizen of this State of this University community. I am proud to make public the respect I have for them and the courage they have shown here. I wish also to express our appreciation to members of the several law enforcement agencies who have performed so well their dangerous and difficult work these past few days, as indeed they did earlier this month when called upon to assist in maintaining order.

The people of this State, the vast majority of our student body, faculty, and staff, and the Administration of this University will not tolerate the utter disregard of the fundamental rights of others by persons seemingly committed to anarchy at best or tyranny at worst. Free men will not tolerate the trampling of others rights or the gross threats to person and property that we have witnessed here in recent days. With an unflinching commitment to this principle and the cooperation of the vast majority of students, faculty and staff we will soon, I am convinced, return peace to this community.

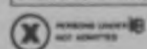

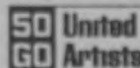

# Gauchos smash Bulldogs, Spartans for PCAA second

## Silvett scores 19 in final game, Emery, Rouse in double figures as Rex-led Gauchos break century mark twice

They call the place Sovine Gymnasium.

None of the Gauchos had ever seen the 84'x50' hardwood on the Dos Pueblos High School campus before but they looked as if they had all grown up in the place. It was only on the orders of the National Guard that they got to see it anyway.

But backed by the inspired play of three graduating seniors, Coach Ralph Barkey's Gaucho cagers won a pair of games this weekend, 117-102 over Fresno State and 104-87 over San Jose State to finish the season 12-14 and pull off a tie for second place in the PCAA with a 6-4 record.

Although the man of the hour was the Gauchos' junior center Doug Rex who 1) won the PCAA scoring title with 219 points (21.9 per game), 2) set a new UCSB career scoring record of 485 points, breaking his 463 of last year, and 3) emerged as the PCAA's leading field goal percentage shooter after going 22-26 over the weekend, it was the Gauchos' three seniors, Ron

Rouse, Bob Emery and Larry Silvett who caught the fancy of the crowd.

Rouse only scored two on Friday although he came back with 10 against the Spartans to close out his collegiate cage career in double figures. Emery had ten against the Bulldogs, 14 against San Jose and was so inspired that he almost scored a lay-up for the Spartans Saturday night, but missed.

Little Larry Silvett, the Gauchos' "Mr. Everything," who had never scored more than 16 in his four years here came up with 19 in addition to his usual fine passing but was unable to crack the magic twenty barrier. He went out in the last minute as did Rouse and Emery to standing ovations from the 1,000 appreciative fans in attendance.

As far as the games themselves were concerned, the Gauchos played some of their best basketball this season. Both the Bulldogs and Spartans were blown off the court early in the game by the Gauchos fine shooting. Friday UCSB was .691 from the floor (76.4 in the first half) and 54.4 Saturday.

Captain Manuel Valdez (142) stuck Davis' captain Ed Winkler in the second period and shut out state's Bruce Wallington 9-0. Dan Thomas (150) picked up 10 team points when he won by default over Davis and then pinned state's Doug Reid in the second period.

At 158 pounds Bruce McCampbell stretched his consecutive winning string to 19 when he downed his Davis and Sac. St. opponents 7-1 and 8-2, respectively. At 167 pounds freshman Pete Van Patten filled in for injured Gordon George, but lost a 9-0 decision to Aggie All-Cal champion Mike Naverte and was decisioned 13-8 by his State opponent. Tom Wallace, dropping down from heavyweight to replace injured John Feeley, pinned Aggie Dennis Zochetthi in the 2nd period, but lost a 8-3 to Sac. St. in the 177 pound division. Steady Ken Linn (190) won a 4-0 decision over Davis' John Linnville and won by forfeit over Sac. St.

The season is not over for the Gaucho matmen as they prepare for the PCAA league tournament next Saturday at San Jose State. UCSB will be slight underdogs in the tournament to a strong Fresno State team.

Next week, the Gauchos travel to Cal Poly (SLO).

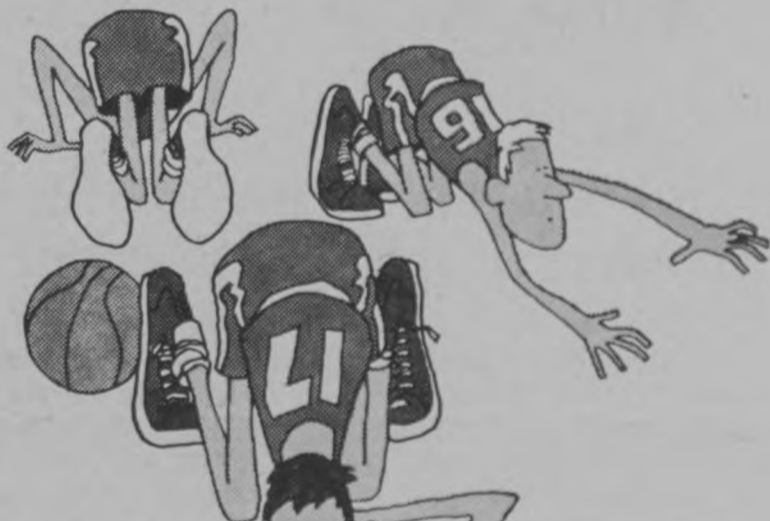

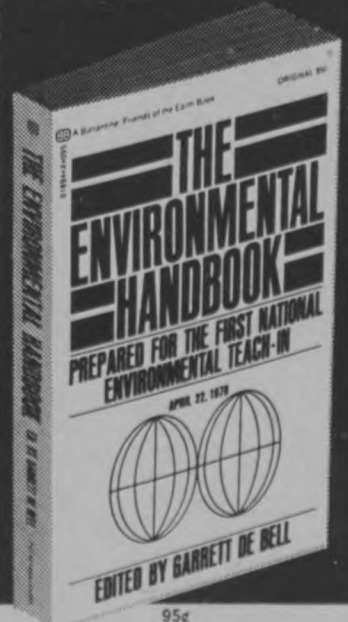

# \$25,000 REWARD

**Bank of America is offering \$25,000 for information leading to the arrest and conviction of the leaders of the mob violence in Santa Barbara.**

We are outraged by the wanton destruction of our premises in Isla-Vista near Santa Barbara. The branch has been gutted by arson on the part of a destructive mob. This was no peaceful demonstration, nor was it a non-violent disruption used as a symbol to redress grievances. It was an outrageous act of violence. It was, in fact, an insurrection against the democratic process of the kind that leads to further violence, bloodshed and anarchy. We are deeply concerned, not only for ourselves, but for the physical and material welfare of all our citizens.

As a preliminary response to the burning of our Isla-Vista branch and the further violence it portends, we are taking the following steps:

1. We are dispatching today an open letter to the Governor of the State and the Mayors of the major municipalities, calling for prompt and effective measures to stop the wanton destruction that is defacing our land.
2. As a potential deterrent, we are filing civil "John Doe" suits against all participants in the burning and destruction of our Isla-Vista branch. We intend to seek and collect maximum civil damages from the participants.
3. We are asking the Grand Jury in Santa Barbara to convene as soon as possible and to issue criminal indictments for arson against all participants in the burning.
4. We are offering a reward, totaling \$25,000 for information leading to the arrest and conviction of the leaders of the mob violence in Santa Barbara. The reward will be in the form of \$1,000 for each participant conviction, up to a maximum payment of \$25,000.
