

# Community Marks Site of Accident With Makeshift Memorial on Sabado Tarde Road; Residents Gather to Remember Victims

The Isla Vista community was shattered this weekend when four people were killed and another critically injured Friday night after UCSB freshman David Attias allegedly struck them with his car while driving at approximately 50 to 60 mph on the 6500 block of Sabado Tarde Road.


Christopher Divis and Nicholas Bourdakis, both 20year-old UCSB students, Ruth Levy, a 20-year-old Santa Barbara City College student and Elie Israel, a 27-year-old San Francisco resident, were all pronounced dead on the scene.

Albert Levy, Ruth's 27year-old brother, was

# 10-Member Jury Makes Final Decision; Envision Designs Wins [Re] I.V. Contest

After nine months of searching and \$60,000 in awards, jurors for the [Re] Vision Isla Vista Master Plan Design Competition selected a California firm's vision of I.V.'s future.

The competition concluded Sunday with the announcement of the winner: Envision Designs. The Berkeley-based firm beat out four finalists, 29 international entries in all, winning an additional \$10,000 and the right to negotiate a contract with the county to produce I.V.'s master plan. All five finalists previously received a \$10,000 honorarium to revise their proposals.

Competition Adviser Bill Liskamm said the 10-person jury

had a difficult time selecting a win-

"The competition was really down to the wire. There were many good things in all the designs, but the jury liked the composition of the Envision scheme," he said. "They liked the light touch of the scheme that wouldn't disrupt Isla Vista, but over time addressed the problem issues."

The jury, made up of five community members and five California planning professionals, not only looked at the proposed designs of the finalists, but at the composition of the design teams themselves, juror and architect Regula Campbell said.

"We looked at the makeup of the teams — their expertise and experience," she said. "We were really looking, not so much at the specifics of the plan, but for the team that would

## **Mourners Congregate for UCSB Student's Memorial**

Friends and family gathered this weekend to celebrate the life of UCSB freshman Patrick "Trick" Wen Tsu Hsu.

Close to 50 friends and family members attended Hsu's memorial Sunday, held in Chemistry 1179. The memorial began with a prayer led by Calvary Chapel of Santa Barbara Pastor Rick Soto, followed by memories of Hsu's life shared by his friends and concluded with a slide show and video presentation documenting his life.

Hsu was found dead Saturday, Feb. 10, in his parents' San Jose residence. An unknown explosive device, which was allegedly mailed to his parents' home, caused his death. The San Jose Police Dept., U.S. Postal Service and the Bureau of Alcohol, Tobacco and Firearms are working in collaboration

### AP Wire Shorts

LOS ANGELES (AP) — In the ongoing battle between the recording industry and Napster, industry officials have brought forth new evidence in an attempt to prove the Internet music-swapping service has cut into their business.

Shipments of CD singles sank by 39 percent last year, according to data released by the Recording Industry Association of America.

"Napster hurt record sales," said RIAA President Hilary Rosen. In particular, Rosen pointed to the drop in the sales of singles — once the format that fueled the music industry — as evidence of Napster's effect.

The industry released the figures after a federal court ruled this month that the service helped users to violate music copyright laws. Financial penalties and an injunction have placed the future of the popular service in question.

Napster Chief Executive Hank Barry said the association is twisting the data to support the recording industry's claim that they have suffered "irreparable harm" at the hands of Napster users.

"In order to argue we've done irreparable harm, it would be great if there were some irreparable harm to show," he said. "We haven't seen a credible survey yet that suggests Napster is hurting CD sales."

Some experts trace the drop in the sale of singles back to the record companies themselves. Industry watchers say that record companies have cut production of an unprofitable product that no longer serves the needs of the industry.

"Napster alone doesn't seem like a fair alibi," said Michael Nathanson, a Wall Street analyst with Sanford C. Bernstein & Co. "It's a combination of things: softness in consumer spending; the hit titles were for such a narrow [audience] that it was a very thin year; and lastly, the Napster factor. You can't put your finger on it."

"To be honest, it wasn't a great music year," said Andreas Schmidt, chief of the e-commerce group at Bertelsmann, which has joined forces with Napster. "There were some isolated events, but we didn't put that much good stuff out."

AMALLAH, West Bank (AP) - Endorsing a Palestinian demand, Secretary of State Colin Powell urged Israel on Sunday to lift an economic "siege" of the West Bank and Gaza Strip as soon as possible.

The constraints, which include a ban on Palestinian workers going to their jobs in Israel and the withholding of tax revenues, do nothing to improve the security situation, Powell said after a two-hour meeting with Yasser Arafat at his headquarters.

"If people are not able to get to their jobs, they become more frustrated," Powell said later Sunday as he flew to Kuwait from Jordan. "Frustration leads to anger and then anger to violence.'

Israel, in an effort to stem attacks on its soldiers and civilians, is using economic pressure as well as firepower. Peace talks have been shelved, and Powell said it will be a long time before they resume.

"We discussed how it is necessary for all sides to move away from violence and incitement and how it is necessary to lift the siege as soon as possible so that economic activity can begin again in the region," Powell said of his meeting with Arafat.

Before seeing Arafat, Powell met Ariel Sharon in Jerusalem but evidently was unable to persuade Israel's incoming prime minister to ease that pressure. Still, Powell said the Bush administration's commitment to Israeli security was "rock-hard."

BELGRADE, Yugoslavia (AP) — Justice officials are investigating alleged false statements by Slobodan Milosevic about his assets, a senior government official said Sunday, suggesting the former president soon may face criminal charges.

Serbian Interior Minister Dusan Mihajlovic told Belgrade's B92 radio that Milosevic was given a house toward the end of his 13 years in power in the city's upscale Dedinje district after signing documents that gave a false picture of his assets.

The government gave Milosevic the luxury residence for his private use.

Milosevic is reputed to have tens of millions of dollars stashed in secret foreign accounts, something he denies. Government officials have indicated he faces investigations and possible charges on alleged wrongdoing as wide-ranging as fraud and war crimes, and Sunday's comments were viewed as the beginning of that process.

"On the basis of forged documents about his ownership rights ... and Milosevic forged them himself ... the government gave him the house that he did not deserve," Mihajlovic said.

If tried and convicted of lying about his assets to secure the house, Milosevic could be sentenced to up to three years in prison.

A close Milosevic aide and top official of the once ruling Socialists, confirmed that the former president expects to be interrogated about the allegations.

"He knows that they will question him soon, in the coming days, about the house," the official said, on condition he not be identified.

Milosevic is also thought to be under investigation for illegally taking state funds out of the country for his private use, and being behind the violent deaths of several of his critics in recent years.

WASHINGTON (AP) - Microsoft will try to convince an appeals court this week that the breakup of the software giant is unwarranted in a high stakes legal showdown that may focus as much on the judge who made the ruling as the legal underpinnings for it.

U.S. District Judge Thomas Penfield Jackson's comments outside the courtroom — comparing Microsoft Chair Bill Gates to Napoleon and suggesting company officials were not "grown-ups" — have injected a new wildcard into the case.

Experts say that makes the job more difficult for government lawyers who are trying to preserve their historic antitrust victory ordering the breakup of Microsoft for anticompetitive practices.

"In conscious or unconscious ways, the court of appeals will feel fewer inhibitions to second-guess Jackson's findings concerning crucial pieces of evidence," George Washington University law professor William Kovacic predicted. Nothing good will come to the government plaintiffs from all of this."

Microsoft has "a 50 percent chance of walking completely" thanks to Jackson's post-trial statements, University of Baltimore law professor Bob Lande said. Before the comments, he gave the government a 2-1

The class should be of interest to those planning careers in business, academia, medicine, law, politics, or comp technology. The first section of the course shall deal with affirmative action in businesses and colleges. We will look at the Court's decision in the famous UC Regents v. Bakke case, and then will examine articles that champion opposing sides regarding preferential treatment. The second section of the course will deal with moral dilemmas concerning privacy, secrets and deception. We shall examine issues surrounding bluffing in business, corporate insider trading lying to very ill patients, and public exposure of a politician's private life. The third section of the class will deal with the topic of professional integrity. The dilemmas that a role morality and an adversary system of law present for ethical members of the bar will be investigated. We will also consider the difficulties that physician-assisted suicide and active euthanasia pose to the understanding doctors have of themselves as practitioners of a healing craft who have taken oaths to do no harm. Then we will look at the debate concerning the social responsibility of those running ousinesses. The Fourth and final section of the course will deal with issues of economic justice. We shall examine the following topics: what is it that makes a contract exploitative; whether the distribution of wealth should be governed by egalitarian norms, or if differences in wealth can be justified on either the basis of merit, entitlement or utility; how intellectual property rights can be justified; and whether there is a need for a new sui generis intellectual property rights paradigm to protect computer programs. The student's grade will be determined by a short paper, section participation, and a multiple choice miderm and final. Outlines of class lectures will be posted on the web. The assigned essays will be collected in a course reader which can be purchased frm Grafik Arts Copy Center for around \$20. This course, Philosophy 6, was incorrectly listed as just "Business Ethics" in the spring schedule of classes. It is a course in buisness and professional ethics. in the investigation.

In an eight-page memorial handout, which included quotes by Emily Dickinson and passages from the bible, many of Hsu's friends shared anecdotes and poems in his honor.

"Words cannot possibly express the emptiness that was created within me the day that Patrick died." undeclared freshman Melanie Conley wrote in the memorial handout. "I do believe, however, that the world is full of countless beautiful and joyous things, many of which remind me of him. I believe that the world's beauty will eventually fill the void inside of me, allowing me to carry Patrick's memory within me wherever I should go."

Matt Hunstock, junior history and business economics major and UCSB Ski & Snowboard Club member, said he had many great memories of the time he spent with Trick since they met in September.

"I miss him a lot. Trick was a good guy — most importantly, he was a good friend. I just enjoyed being around him — it never got old," he said. "I only knew him for a short time, but the memories will stick with me forever ... whether it was a conversa-

tion about girls, shaving or making fun of my Ski & Snowboard Club flier. I'll always remember that."

Jennifer Coppolino, senior bio-psychology major and Ski & Snowboard Club vice president, said she would always remember Hsu and his ability to easily make friends.

"He was an incredible and very special person," she

said. "He could light up a room by just walking into it ... I know myself that he will forever be with me and I will never forget him."

Hsu had a deep spiritual connection with Christ and expressed a deep affection for his friends, said junior history major John Yamazaki, coordinator for the Campus Crusade for Christ at Francisco Torres.

"There was something different about Trick; he was really deep," he said. "We had a deep conversation about the meaning of life. He talked about his concern and love for his friends ... He really shared

with me that he loves you

"I will never forget his laugh or the ways he could bring such happiness to our lives in little ways," freshman biology major and friend Jessica Atwell wrote in the memorial handout. The memorial ended with a procession to Campus Point, one of Hsu's favorite surfing spots, where flowers were placed in his memory.




### In Memorium

Friday Night's Tragedy Deeply Impacts Community Still Reeling From a Year of Loss

t has been a long, hard year at UCSB; we have lost seven of our friends and classmates in the last two quarters. Now, after Friday's tragedy on Sabado Tarde Road, the mood in Isla Vista is perhaps as somber as it has ever been. The sky is dark, the clouds are gray and the air is heavy with sentiment. Three days on, the community shares a mixture of disbelief and sorrow. We mourn collectively for such a seemingly senseless loss of life, but extend our deepest sympathies to the families and friends of Christopher Divis, Nicholas Bourdakis, Elie Israel and Ruth Levy.

No words can console the loved ones of these victims, or the three other students who died tragically this year: Miyaka Geh, Patrick Hsu and Dave Lindsay. But, if we can glean anything positive from these deaths, it must be the strong sense of community cohesion reflected in students' actions this weekend. Many of us experienced friends calling late Friday night to check on our safety. It seemed that within a couple of hours the whole of Isla Vista was aware of the tragedy. Bunches of flowers mark the site on Sabado Tarde and people still gather there to say goodbye or search for some meaning amid the horror.

In contrast to how the mainstream media has been reporting the story, this was not an accident waiting to happen. This was not an inevitable consequence of livStaff Editorial

ing in a "party town," nor should it become an excuse to push an anti-alcohol agenda. Irrespective of Attias' state of mind or level of intoxication, it was a random act of violence; but more importantly, it is a deep loss inflicted upon an entire community. This week should be in remembrance and reflection of those who died on Friday. Let us not lose sight of the human face in this tragedy. While our anger seems warranted, rashly assigning blame won't assuage the grief. Our thoughts should be with Albert Levy, who is still in critical condition in Santa Barbara Cottage Hospital, and those mourning the loss of young lives ended too soon.

The Nexus would like to convey gratitude and

tremendous respect for the law enforcement and emergency response personnel who acted with efficiency, compassion and unwavering professionalism during such a highly traumatic incident. Similarly, while witnessing this apocalyptic scene, the bystanders responded immediately, subduing the driver and attending to the victims. We do not live in an apathetic community, and people's actions and reactions this weekend only reinforce this point.

While we cannot guarantee to print all the condolence letters we receive, we will gladly pass them on to Albert Levy or the families of the four victims. Please clearly note this on your letter if you would like us to do so.

listen carefully to the concerns of the community. We want them to focus on how to solve problems and carry forth those special qualities that make Isla Vista a special place to live."

Liskamm said Envision Designs' plan was superior to those of the other four finalists because it focused on key issues like transportation and housing

"The jury really liked the attention that was given to transportation and parking," he said. "They liked the attention to the downtown area. [Envision Designs] recognized the tremendous need for additional housing, and they addressed that in an innovative way."

The county's next step in the master plan process is to finalize the paperwork with Envision and prepare for a number of public meetings to gather community input.

"The next two months will be spent drafting a contract with Envision Designs and assembling a Community Advisory Committee," County Supervising Planner Lisa Plowman said. "Then we will hold nine months' to one year's worth of public meetings. We will be keeping the community updated and involved."

Designs Envision architect David Sargent said their plan was revised before it was submitted and refocused on important issues of transportation and parking.

"During the weekend at Berkeley there was a lot of debate over the transportation scheme," he said. "We were focusing on building, and our transportation consultant was relentless in stressing its [debate with the transportation consultant], which is why we're here today. I believe this shows we are open to sugges-

tions."

Isla Vista's parking shortage was a major concern addressed in the Envision design, Sargent

"Isla Vista has lots of density and not a lot of parking," he said. "At first our issue was how to get more parking, but our transportation consultants focused on how we could improve street fluidity. We didn't want to set up a situation that encourages students to bring cars — a lot of students don't have or need cars."

Sargent said that Envision Designs is open to and encourages community input.

"Most of what we need to hear from the community, we haven't yet," he said. "We need the comimportance. We lost that munity to start the process. We had to come in with drawings for the competition, but we really want to draw the community's ideas."

transported to Santa Barbara Cottage Hospital and is listed in critical condition in the intensive care unit, but is expected to survive. Albert Levy and his friend Israel were in I.V. visiting Ruth Levy for the weekend.

Attias was driving eastbound on Sabado Tarde when he allegedly ran a stop sign at the Camino Pescadero and Sabado Tarde intersection and struck nine parked cars and the five pedestrians at 11:08 p.m., California Highway Patrol Public Information Officer Mike Muell said. Attias is currently being held at the Santa Barbara County Jail on one count of vehicular homicide without the possibility of bail, and is scheduled for arraignment on Tuesday.

"He ran that stop sign before he hit the cars. He hit nine cars in a row. They were all parked in front of each other on the [south] side of the road. He hit about probably one or two cars first and then he started hitting the pedestrians, and he was hitting them as he continued to sideswipe the seven other cars," Muell said. "This is the most gruesome accident we've ever seen."

Witnesses at the scene immediately called 911 and began to check the pulses of the victims before ambulances arrived. After concluding Albert Levy was the only victim still breathing, an anonymous witness administered CPR to him. Nicholas Gadouas, an I.V. resident and SBCC student, said when Attias' vehicle, a 1991 black Saab, came to a stop, the suspect jumped out of the car and began challenging witnesses around him to fight.

"By [the time the ambulances arrived] the guy was ranting and raving and pulling at his clothes. He was saying stuff like, 'This is the dark side, I'm the dark angel, I'm the angel of death,' and 'This is a government ploy to scare you, don't believe the lies.' He went to pick up the girl he hit; he kind of picked up her arm and let

go of it," Gadouas said.

"By the time they were here, the police got him within five seconds. Other people were fighting with him. A hundred or so people were psychologically damaged within that one moment," Gadouas said. "People were kicking the shit out of him; if police hadn't arrived when they did, someone would have killed him. There was a circle around him, and every time he tried to get out, people would push him back and he would jump right up, and he's a pretty small guy."

Muell said Attias was uncooperative after his arrest and showed signs of being under the influence of a controlled substance, including dilated pupils and an abnormally high heart rate. Results from

blood tests obtained Friday night will not be available until later this week.

"When he realized law enforcement was involved, he became very uncooperative, wouldn't do what was asked of him, refused to answer any questions, refused the tests that we tried to give him. We even had to forcibly take a blood sample from him because he wouldn't," Muell said. "We do believe that he probably was on something, but we don't have anything to make us believe it was alcohol that he was on. Our drug recognition experts do believe he was under the influence of some sort of narcotic or drug. That's why the blood samples were obtained, so we can test that and see exactly what it was."

Attias was aggressive towards witnesses and law enforcement officers and did not appear at all concerned about the welfare of the victims, said senior business economics major Adam Smith, a resident on the 6500 block of Sabado Tarde.

"I don't know what they decided he was on, but he wasn't slurring, or he wasn't in that drunken state. He seemed very mellow and it seemed like he knew what had gone on," he said. "Actually, one of the things that's gonna stick in my head was when the policeman was putting him in the back of the cruiser there was a line of us on the sidewalk and on the balcony, and he just turned to the whole group and said 'Peace out,' and then he got in the car. That was one of the things I'll never forget, because he was standing 15 feet from us and he turned to us with no regard for what he had just done."

Hundreds of I.V. residents arrived at the scene in the hours following the accident. Joe Cordoni, a sophomore dramatic art and communication major, said he was baffled such a horrific and violent incident occurred in I.V.

"I can't even believe it. This is a random act of violence - the ultimate evil, because he had no idea of the background of the victims. This is just spontaneous violence. I'm devastated right now," Cordoni said. "Right now as we stand here, fuck, I'm totally dumbfounded. It's disgusting. I've seen people shot in front of my face; I've passed by dead bodies on the freeway. But this stuff hits home harder than anything right now these parents don't know their babies are

ceased."

Attias had a previous history with drug abuse and behavioral problems, according to Julia Himberg, a sophomore film studies major. Himberg said Attias was in a drug and behavioral rehabilitation program in Vermont approximately three years ago with her sister's roommate.

"[My sister's roommate] was saying to me that obviously she was surprised, but she wasn't as surprised as we were, con-

sidering she was in a rehab program with him. She said that not only was it a rehab program for drug and alcohol abuse, but also for behavioral problems and issues in modification, and obviously this was related — he was more on a mission, that was what she was suggesting to me," Himberg said. "I certainly know what was running through my mind in part was: 'Was this just a freshman who had been a good

kid all along, and all of a sudden he just got drunk one night and did something stupid, or was this just a pattern with him?' And it sounds more like he had a pattern."

UCSB Chancellor Henry Yang arrived with his wife at approximately 12:30 a.m. and began to set up counseling for those affected by the accident.

"My wife and I got out of bed and drove here right away. Student Health Center Director Cynthia Bowers is also on her way to bring counselors," he said. "We are trying to be of some help for this terrible, terrible tragedy. I'm so shocked and so saddened by this tragedy."

In a statement Sunday, Yang said counselors would be available this week at the Career and Counseling Center, and today the flag at Cheadle Hall will fly at half-staff in memory of the victims.

Flowers and candles began flooding the scene of the accident Saturday morning, and friends of Bourdakis and Divis gathered Sunday for an impromptu memorial. St. Mark's Church will hold a candlelight vigil tonight at 8 on Sabado Tarde.

In a written statement to the *Daily Nexus*, friends said Bourdakis, a geography major, had a passion for flying airplanes and worked at an airfield in San Francisco while at home last summer. "Those who knew him speak very highly of this young man who brightened everyone with his humor and presence."

Divis, a sophomore mechanical engineering major from Vista, CA, was remembered by his high school friend Cody Webster as a hardworking student who had a passion for animation and photography.

"I've known Chris for four years. My first reaction to all of this is it wasn't fair. Chris out of all of us, aside from being smart and funny, applied himself, you knew he was going somewhere in life. He was a very, very outgoing person and had one heck of a sense of humor," Webster said. "The last time I saw him was over Christmas Break, but we would talk on the phone at least once a week. One of the hardest parts is that I had no clue that would be the last time I ever saw him, there's so much more I wish I could have told him, like what a great person he was. I feel anger towards the guy who was driving. His life is over and I feel great about


