## A.S. PRESIDENTIAL CANDIDATES



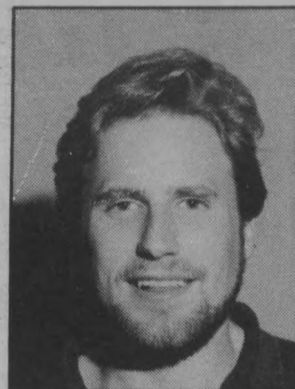
**Brittany Oates**

**Guy A. Harrell**

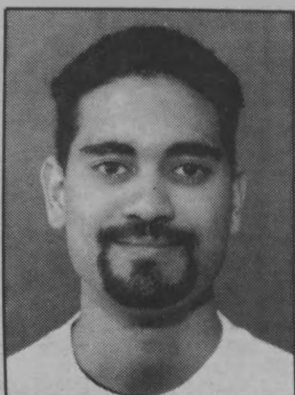

## INTERNAL VICE PRESIDENT



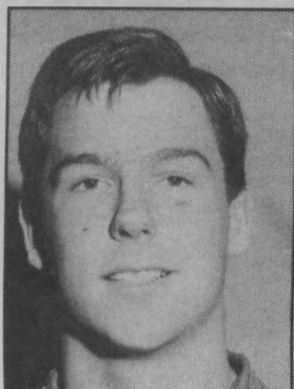

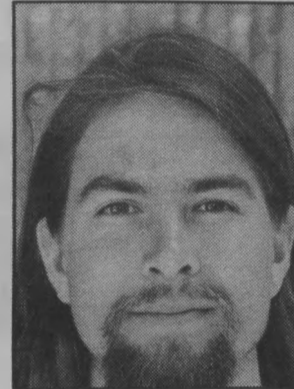

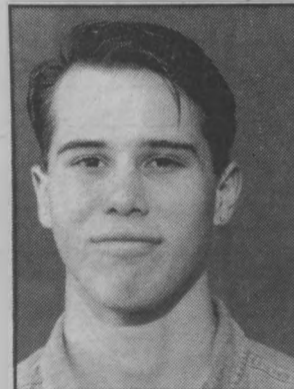

### Shawn Flynn

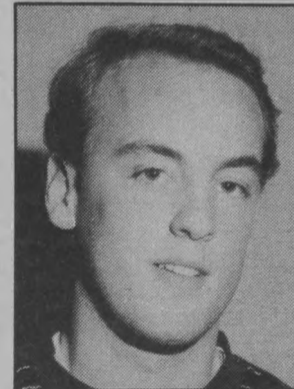

## Associated Students Elections Information — What IS Leg Council?

The Legislative Council is made up of:  
5 Representatives At-Large  
3 On Campus Representatives  
12 Off Campus Representatives  
1 Representative for University Owned Housing

The Duties of the Legislative Council members include:

- Supervise and maintain the policies, properties and conduct of the Associated Students.
- Have authority over the responsibility for all Associated Students' revenues and expenditures.
- Be empowered to override a Presidential veto by a two-thirds (2/3) majority approval of the voting membership.
- Be empowered to authorize the expenditure of investment reserve funds by a three-fourths (3/4) majority approval of the voting membership.
- Be empowered to dismiss appointees of the President, the Presiding Officer, and the Judicial Council by a two-thirds (2/3) majority approval of the voting membership, unless otherwise provided herein.
- Attend all regularly scheduled Legislative Council meetings.
- Serve on at least two (2) standing committees.
- Hold a minimum of three (3) office hours a week.
- Undertake at least one (1) major project during their term of office.

The Executive Branch is made up of:

- President
- Internal Vice-President
- External Vice-President
- Vice President for University of California Student Association

The Duties of the Executive Branch include:

- The President shall:
  - Be the Chief Executive Officer of the Associated Students and shall coordinate and be responsible for the functioning of the A.S. Executive Director.
  - Serve as official representative of the Associated Students in all campus, systemwide, local, state and federal matters, unless otherwise provided herein.
  - Deal with all student affairs.
  - Appoint the Chairpeople of all boards, commissions, committees, and other agencies of the Executive Department from the membership of the Associated Students.
  - Name the Chairperson of the Judicial Council from its membership subject to a two-thirds (2/3) majority approval of the voting membership of the Legislative Council.
  - Appoint all student representatives to University administration, faculty, staff, or other advisory bodies.
  - Formulate an annual budget to be submitted to the Legislative Council for approval by the fifth (5th) regular meeting of Spring quarter.
  - Be a non-voting ex-officio member of all boards, commissions, committees, and other agencies of the Executive Department.
  - Be empowered to veto legislation of the Legislative Council within two (2) days of its adoption.
  - Be empowered to appoint a Cabinet of Advisors not subject to Legislative Council ratification.
- The Vice President for Internal Affairs shall:
  - Serve as the Presiding Officer of the Legislative Council except when the office of the President becomes vacant.
  - Serve as the representative of Associated Students in all internal affairs.

- Advise and inform the President and the Legislative Council on all campus matters.
- In the event that the office of the President becomes vacant, serve as President until a new President is duly elected.

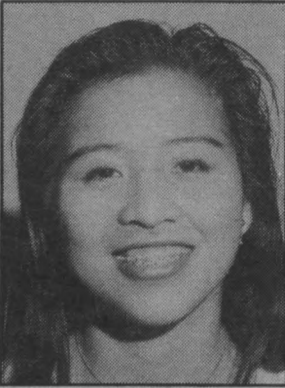
C) The Vice-President for External Affairs shall:

- Serve as the official representative of the Associated Students on all Isla Vista and Santa Barbara County affairs.
- Coordinate all Isla Vista and county of Santa Barbara issues that indirectly or directly affect UCSB students.
- Advise and inform the President and Legislative Council on all local external matters and affairs.
- In the event that both the offices of the President and the Vice-President for Internal Affairs become vacant, serve as President until a new President or Vice-President for Internal Affairs is duly elected.

D) The Vice President for the University of California Student Association shall:

- Serve as the official representative of the Associated Students on the University of California Students' Association (UCSA) Board of Directors.
- Serve as the representative of Associated Students in all state, federal and UC systemwide matters.
- Advise and inform the President and Legislative Council on all state, federal and UC systemwide matters.
- In the event that the offices of the President, the Vice-President for Internal Affairs and the Vice President for External Affairs should become vacant, serve as President until a new President or Vice-President for Internal Affairs is duly elected.

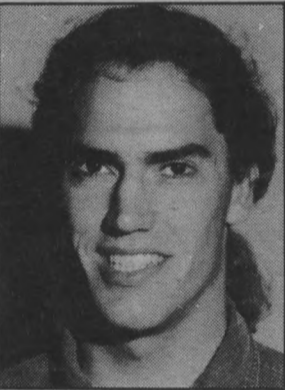


## Brian Lawrence

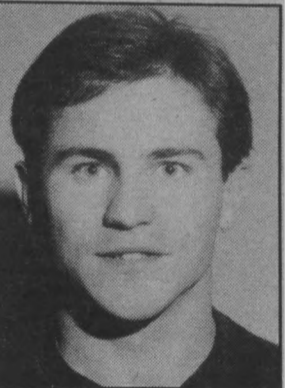
## Christopher W. Stebbins

## Erin O'Brien

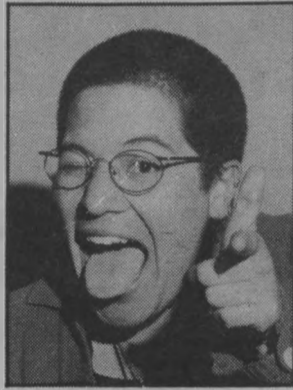

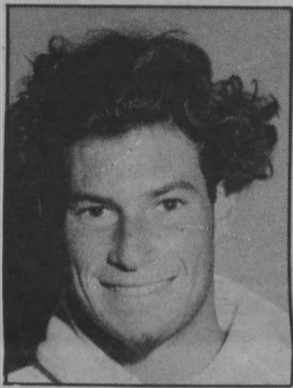
## Anita Miralle

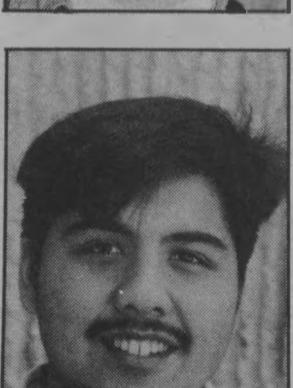
## Woody Clark

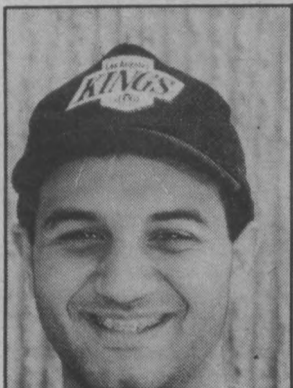


# ON CAMPUS REPRESENTATIVES

### PRO:

In two recent elections, an overwhelming majority of UCSB students voted to support the Student Health Service (SHS)'s need for continued financial assistance. In 1991, the Associated Student Body passed an initiative for a \$12 lock-in fee by an impressive 70.7% yes vote. In 1993, this initiative was reaffirmed by an even greater 88.6%.

Former AS Presidents Michael Chester and Aaron Jones both supported these fee initiatives because they believed in the vital function the SHS performs in its provision of acute and on-going health care to students. Both also believed that a lock-in fee was essential to ensure the SHS's ability to provide affordable quality health care to all students.

At a time when students face continuing fee increases across the board, it is more important than ever to spend money wisely. For this reason the SHS Advisory Committee (SHAC) wants you to understand the ramifications of this initiative.

During the last four years, the fiscal situation of the SHS has worsened despite lock-in fee income. Medical inflation has risen at a rate of 10-15% per year while SHS registration fee funding has been cut by \$618,083. The SHS building, which is twenty years old, is facing massive maintenance and capital

improvement costs in order to remain in compliance with state and federal regulations. Sources of one time funds that have been traditionally used to fund major building needs are becoming scarce. If the SHS is to remain open, these maintenance repairs, none of which are cosmetic, must occur.

The SHS can increase its funding base in three ways: by increasing lock-in fees, user fees or both. In 1993, a new user service fee for lab, x-ray and specialty visits was instituted because the current lock-in fee could not offset funding cuts. It is anticipated that in 1994, a \$15 user fee (assessed on the first visit each quarter) will also be reinstated unless other forms of funding are initiated.

As an alternative to these user fee increases, the SHAC has recommended that a constitutional initiative be placed on the Spring ballot requesting students to raise the SHS lock-in fee. Students who support this initiative will have two choices as to how much the fee should increase: to \$17.50 or \$20. If the lock-in fee is increased to \$17.50, the revenue generated would be equal to the anticipated revenue generated from a \$15 per quarter user fee eliminating the necessity for that fee at this time. User service fees for the lab, x-ray and specialty visits would continue. If the fee is raised to \$20, this increase in revenue would offset the need to generate additional revenues from a quarterly user fee and from specialty visits, X-ray and lab processing fees. If this initiative fails, students will continue to pay the existing \$12 lock-in fee; in addition, all charges currently in place will continue and the \$15 quarterly user fee will be instituted.

The purpose of this initiative is to give students a choice as to how to pay for their medical care. User fees place the burden of payment on those who require health care, either as a onetime quarterly fee and/or as new user service charges. A lock-in fee, on the other hand, helps keep medical costs at UCSB low and accessible to all students by spreading the cost of health care across the entire student body through a lower mandatory charge.

Even though the State's funding situation continues to be uncertain, the SHS and the Division of Student Affairs remain committed to minimizing out of pocket medical costs to students. This is why despite even more severe economic conditions facing student voters today than in 1991 and 1993, the cost of obtaining health care at the SHS is still dramatically less than typical community rates, even with lock-in and user fees.

Did you know that fifty years from now someone will be able to read what you are now reading? That's right, newspapers consume over 1/3 of the landfill space and they're not biodegradable. That is why newspapers are still legible a half-century later. Newspaper recycling at this school is extremely minimal at best. Money is needed to provide adequate facilities and labor to tackle this problem.

UCSB is easily the county's largest employer. So one can easily conclude that we are also the county's largest trash producer. Because of that, we owe it to ourselves to stop being part of the problem, and instead be part of the solution. In the meantime, landfill space and natural resources are disappearing rapidly in order to satisfy our present lifestyles. This is a problem that we cannot hope will just go away by itself, and this lock-in is our chance to deal with it, instead of a running away from it.

There are other far reaching effects that occur as well, such as ENVIRONMENTAL RACISM. This means that a very disproportionate amount of landfills and toxic-waste facilities end up in predominantly African-American and Latino neighborhoods. This occurs, because they often do not have the resources or power to stop these facilities from being put in their backyard.

There are many other schools that have comprehensive recycling facilities. I think it's a crime that UCSB does not yet have one. This facility could employ ten student. This lock-in would only cost \$2.25 a year. I doubt that you can find a burrito in Isla Vista cheaper than that. I'll admit that I feel there are some lock-ins that have questionable merit. However, I feel that a recycling lock-in would be a very worthwhile investment in our planet's future. There was a poll that asked Americans if they would be willing to have consumer prices increase, in order to protect the environment. Eighty percent said YES! So let's be part of the mainstream and vote YES!

Thus, we entreat you, the students of UCSB, with the proposition of helping fund a second regular unbiased publication, here for your disposal, for the price of a phone call or two.
