Initiative, Referendum, and Recall: Do you approve of a change in the Associated ents Constitution to be worded thusly

ARTICLE VIII - SPRING GENERAL, SPECIAL, AND RECALL ELECTIONS **PROCEDURES**

SECTION 1. SPRING GENERAL ELECTION

A) "The Spring General Election," which shall occur on the fourth week of Spring Quarter, must consist of Associated Students Executive Officer and REpresentative Elections. In addition, the following categories may

- 1. Constitutional Amendments
- 2. Special Election
- 3. Recall Election
- 4. Plebiscites
- 5. Any other categories deemed necessary by the Elections Committee with the approval of the Legislative Council

B)All ballot measures must be ratified or approved (as appropriate) by the A.S. Legislative Council no later than the first week of Spring Quarter.

SECTION 2. SPECIAL ELECTION

A) "Special Elections" procedures shall always be adhered to and used in the following circumstances: Constitutional Initiatives and rEferendum. 1. A Special Election will be held if a petition is presented to the Le gislative Council.

a. For an initiative, the petition must be signed by fifteen percent (15% of the Associated Students Membership.

b. For a referendum, the petition must be signed by five percent (5%) of the Associated Students Membersh.

c. A majority (50% + 1) vote with at least twenty percent (20%) of the Associated Students Membership voting shall be necessary for adoption of an initiative or repeal of legislation.

d. Initiatives not adopted or legislation not repealed in the above manner shall not be introduced again for at least one (1)

e. A Special Election shall be held no more than one (1) time per quarter, at a date determined by the Elections Committee and the Executive Director with final approval by the Legislative

SECTION 3. RECALL ELECTION

A)Elected Officers of the Associated Students shall be subject to a "Recall Election" upon presentation to the Legislative Council of a petition signed by ten percent (10%) of the Associated Students membership eligible to vote for a specified officer. Members of the Judicial Council are subject to recall by presentation of a petition, signed by ten percent (10%) of the Associated Students Membership to the Legislative

a. If a "Recall Election" petition is presented to the Legislative Council by their fifth (5th) meeting of either the Fall or Winter Quarters, an election must be held before the end of that quarter. If the petition is presented after the fifth (5th) meeting, an election must be held by the fourth (4th) week of the following quarter, or during the "Spring General Election," whichever

Changing the External Affairs Job Description to Create Two Positions: Shall rent Article IV Section 2 C) which reads:

C)The Vice President for External Affairs shall:

1)Serve as the official representative of the Associated Students on the University of California Student Association (UCSA).

2) Serve as the representative of Associated Students in all external

3) Advise and inform the President and Legislative Council on all systemwide, local, state, and federal matters

4)In the event that both the offices of the President and the Vice President for Internal Affairs become vacant, serve as President un-til a new President or Vice President for Internal Affairs is duly

CThe Vice President for External Affairs shall:

1)Serve as the official representative of the Associated Students on all Isla Vista and Santa Barbara County affairs.

2)Coordinate all Isla Vista and County of Santa Barbara issues that indirectly or directly effect UCSB students.

3)Advise and inform the President and Legislative Council on all local external matters and affairs.

4) In the event that the offices of the President and the vice President for Internal Affairs become vacant, serve as President until a new President or Vice President for Internal Affairs is duly elected.

D) The Vice President for University of California Student Association shall: 1) Serve as the official representative of the Associated Students on the UCSA Board of Directors.

> 2) Serve as the representative of the Associated Students in all state, federal and UC systemwide mu

3) Advise and inform the President and Legislative Council on State, federal and UC systemwide matters

4)In the event that the offices of the President, the Vice President for Internal Affairs and the Vice President for External Affairs should become vacant, shall serve as President until a new President or Vice President for Internal Affairs or Vice President for External Affairs is duly elected.

Constitutional Amendment Regarding Petitions: Should the petition process be

amended to work as a function of voter tumout rather than total student population,

the ASUCSB Constitution shall be amended as follows ARTICLE VIII - INITIATIVE, REFERENDUM, AND RECALL

SECTION 1. INITIATIVE A)The Associated Students shall have the power to initiate legislation by

means of a petition signed by its members in a number equal to fifty plus one (50%+1) of the total number of its members who voted for the office of Associated Student President in the immediately preceding Associated Student General Election, and presented to the Legislative

SECTION 2. REFERENDUM

 A)Any legislation adopted by the Legislative Council may be subjected to a referendum vote of the Associated Students upon presentation of a petition signed by its members in a number equal to fifty percent plus one (50% + 1) of the total number of its members who voted for the office of Associated Student President in the immediately preceding Associated Student General Election to the Legislative Council

SECTION 3. RECALL

A) Elected officers of the Associated Students shall be subject to recall upon presentation to the Legislative Council of a petition signed by its members in a number equal to fifty percent plus one (50% + 1), except Executive Officers which will be in a number equal to ten percent (10%), of the total number of its members who voted for the said office in the immediately preceding Associated Students General Election. Members of the Judicial Council are subject to recall by presentation of a petition, signed by ten percent of the Associated Students' Membership, to the Legisla-

ARTICLE IX — AMENDMENTS

SECTION 1. METHODS OF PROPOSING AMENDMENTS

B)By a petition signed by members of Associated Students in a number equal to fifteen percent (15%) of the total number of its members who voted for the office of Associated Students President in the immediately preceding Associated Students General Election.

nt position, this position requires analytical and exceptional commu skills. Having to deal with the University of California Student Association (UCSA), state legislature and the UC Regents (in my opinion), is not only a thankless task, but it takes great amounts of time. CON REG FEE INCREASE

The following is the opinion of the President of the Associated Students. The position of opposing the proposed 40% increase is completely in line with the position that was taken by the Legislative Council of the Associated Students. The information that is presented to you in this statement concerning the state and UC deficit, is for the

most part factual. However, some of the theories are only possible conclusions that could be offset if the state were to find additional revenues.

"Why an increase in registration and educational fees?" This being a touchy queswhy an interest in logistation and educational teet. This being a totally question for students and administrators alike, it is also important to ask, "Who is asking who to burden the costs of attending the University of California? If you asked UC President David Gardner and every UC Chancellor, your answer might be, 'to preserve the educational excellence of the university.' While President Gardner opted to reduce the staff force of UC by 1000 employees, not fund the Environmental Impact Report for the 10th UC school (thereby stalling construction plans yet another year), withhold for the staff process have reported to the contraction of the contrac withhold faculty salary increases by 6 months and increase fees by 40%, he and the other Chancellors found it appropriate to raise their salaries twice in less than 15 months. Along with these and many other program cuts, there is a distinct possibility that this meager 40% increase in fees may become as large as 50%, if the state budget becomes any worse. Furthermore, with the state budget looking so bleak for the next few years (and the simple fact that our politicians in office can never provide for all state needs), our registration fees (which we can now begin to call tuition), may double within a two year period. Is this reason enough for you to oppose the proposed

As I have eluded to, many of our campus' programs will continue to be underfunded, while several programs will be forced to make additional cuts. Programs such as the Tutorial Center have already been hit with major funding cutbacks this year. Next year with an even larger state deficit (estimated at approximately \$12.6 billion dollars), I wonder if any of our programs that we believe to be necessary, will exist after next year. With further increases in fees and increasing costs in living expenses (much like the Tutorial Center), I wonder if our students will be able to afford to at-

tend this "state-funded university."

"How will the registration fee increases affect the diversity of our campus?" In order for the university to attract underrepresented low-income and the lower-middle to middle class students, it is important to keep our fees as maintainable and as low as ssible. To achieve the goals of diversity, the university must be as accessible and affordable as humanly possible. By increasing fees we can only mourn for the many graduate student that will be unable to attend the UC, and many support programs that will be forced to reduce services, and the numerous students that will need more loans and financial aid, simply to receive a higher education that should be provided for mostly by state dollars. But by voicing our concerns opposing he fee hike, we may be able to show the legislature that we completely condemn the actions of the UC Regents and seek their support in keeping our fees low and affordable. And if they should question our motivations to tax ourselves for certain programs (I.E., The Health Center, Childcare Center or Special Services), tell them, "We tried it your way and it hasn't worked. Because of this, we've found it necessary to tax ourselves to ensure the preservation of programs that we support, while at the same time, you felt not important enough to fund."

These are just a few reasons why we must oppose and demonstrate our opposition to the proposed 40% fee increase.



So if you want more than posters and empty campaign promises YOU WANT RACHEL DOHERTY FOR A.S. PRESIDENT!!!!!!




Jonathan Barron

UCSB's student media — the Daily Nexus, KCSB and the La Cumbre yearbook — survive wholly or in part because of student contributions to them. Without this student dent support the campus media would not be able to continue to provide quality, innovative publications and programming at its present high standards. The combined \$5.14 that constitutes the student media lock-in are distributed as follows: Daily Nexus — \$.85, La Cumbre — \$.84, KCSB — \$1.20 and Communications Personnel \$2.25. Each of these monies directly affect the quality of the student media, and are thus integral in the media's ability to reach students with pertinent and entertaining information. And at the low price of the lock-in over the course of a year, reaffirming the lock-in measure is a wise investment for the UCSB student body.

> CON Daily Nexus Lock-In

Each quarter, we give eighty-three cents to "our" campus newspaper. We spend two dollars and forty-nine cents each year so that the Nexus can afford to function. Roughly \$39,840 of OUR money each year is immediately given to this paper. WHY? Open the Nexus any day and you'll find nearly half of each issue is advertis-

ing. According to the Goleta Sun, who each day prints the Nexus, each side of a page costs around two hundred fifty dollars to print. Seems like quite a lot, when you consider that an average issues is fourteen pages or more. But then consider their advertis-

sider that an average issues is fourteen pages or more. But then consider their advertising rates.

The open rate (meaning for people like you and me who don't have a contract with the Nexus) is seven dollars and eighty cents per column inch (we won't even consider classified ads, which go for about thirty-two bucks per column inch). So for a full page ad (about 100 column inches) you'd expect to pay seven hundred and eighty dollars. Wait... each page only costs two fifty to print. Yes, you added right,... they make roughly five hundred and thirty dollars pure profit for every page of ads they sell. WHY? Assuming they sell only seven pages of ads for an average sized issue, that's almost four thousand dollars profit every publishing day. If you're still following me, multiply that by the 147 days they publish. Each year they make \$545,370 in profit, on top of the \$39,840 they squeeze from students. WHY?

It's easy to say that if we give them our money, then they are responsible for serving our needs. WRONG. Read the disclaimers: "opinions expressed are the individual contributor's...(and) do not necessarily reflect those of UCSB, its faculty, or its student body." They think they are under NO obligation whatsoever to accurately report student opinion.

So WHY do they ask for our money every two years? Good question. Perhaps it'll go into the already exaggerated hourly wages of the Nexus editors' paychecks. Editor-in-chief Larry Speer is the highest-paid student employee on this campus. No other editor is exactly hurting for money, either, judging by their clothes, cars, and apartments. The Nexus Editors do nothing for the students who symbolically sign their paychecks except serve their own bizzare political viewpoints and spoon-feed we students their daily blend of trash, tripe, bad cartoons, inside jokes, and fluff.

But a better question is this: WHY do we allow them to take an exorbitant \$40,000 from us each year? So we can continue to receive the one-sided new coverage we've.

from us each year? So we can continue to receive the one-sided new coverage we've all grown accustomed to? So they can continue to misrepresent and misquote? So we can continue to see all those pretty ads every day? So we can continue to read responsible journalism like how to make a pipe bomb at Builder's Emporium? So we can keep on reading biased editorials that do not reflect the opinions of the students who

pay for the paper it's printed on? WHY?

WHY, indeed? WHY do we vote yes every two years? IS it out of an idealistic hope that they'll get better? WRONG. The Nexus gets worse and worse every year. Let's do the campus a favor and vote NO on the Nexus reaffirmation. We figured it out ourselves... they don't need the money. They make \$545,370 every year just from advertising. Surely that's enough money to divide up between the handful of editors. And that relieves them of the moral burden of serving the campus... they can continue

to serve themselves as they are used to doing.

PRO F.A.C.E.S. Lock-In

Only in its second year at UCSB, F.A.C.E.S., for Faculty and Course Evaluation Survey, has already accomplished what it originally set out to do: give students more information than previously available about G.E. Courses. Now, it aims to do more: cover more courses, develop its own surveys with questions students want answers to; and be available free to UCSB students. By voting yes on the constitutional lockin fee of fifteen cents per quarter, students can ensure that all this happens and eventu-

F.A.C.E.S. has already proven itself to be a reliable, objective publication to UCSB faculty. Professors have given F.A.C.E.S. their vote of confidence by helping to make sure F.A.C.E.S. has the most detailed information possible about the courses they teach and by allowing us to use their student evaluations for publication in F.A.C.E.S. Expect next year's F.A.C.E.S. to have over twice as many courses

surveyed: participation from faculty has doubled and is still rising.

Another goal of F.A.C.E.S. that will be realized if students support the lock-in fee of 15 cents is the use of our own surveys. Currently F.A.C.E.S. must use department tal evaluations that are the property of instructors, so the instructors may opt not to reveal what students have said about them. Fifteen cents from each undergraduate will enable F.A.C.E.S. to proctor its own surveys every quarter that can address important educational issues. Given the current climate at UCSB, F.A.C.E.S. has chosen to ineducational issues. Given the current climate at UCSB, F.A.C.E.S. has chosen to include a question asking students about a professor's sensitivity to ethnic and gender-related issues and tolerance of alternative viewpoints and lifestyles. These questions deserve to be addressed, since they affect the quality of education UCSB students receive, and F.A.C.E.S. is an excellent vehicle to provide this information. Also asked in the survey will be questions about workload, difficulty of the course, strengths and weaknesses of the course, and the professor's ability to interest students in the material. Armed with this new knowledge students can make much more informed choices about which courses are suited to their needs. If the proposed budget cuts are implemented, UCSB students will be paying up to

If the proposed budget cuts are implemented, UCSB students will be paying up to 40% more for the same old education (and fewer services designed to help students achieve academically). It is vital that students make an attempt to get more for their money in the years to come. F.A.C.E.S. can help in many ways:

Students must have a voice in the educational decision-making process. Too

often no opportunity for input is given to students in curriculum-shaping, personnel/tenure review, and other relevant academic issues. F.A.C.E.S. can help provide this opportunity by establishing a regular forum for students to give their opinions on courses and professors. Also, far too few faculty acknowledge the importance of teaching evaluations by students, and F.A.C.E.S. can improve the communication process between students and faculty: each can become aware of mutual needs and expectations. F.A.C.E.S. can also force professors to be conscientious and responsive in their teaching, or else risk getting a poor evaluation from their students in F.A.C.E.S., and consequently fewer people will take that course in the future. Faculty must become accountable to the students they serve.

The philosophy behind F.A.C.E.S. is that students are consumers who are shelling out big bucks for a product: an education. As consumers, we have a right to know what we're buying before we buy it. Before F.A.C.E.S., we were forced to make course choices based on little else than a two-sentence description in the General Catalog. Now that F.A.C.E.S. is in operation, students have a dependable source of information, a sort of "think before you buy" guide.

Vote yes on the fifteen cent lock-in fee. And Let the Buyer Beware.

The Bike Shop is currently suffering from a deficit and is unable to continue this worthy and noble cause. A positive student vote on the upcoming Bike Shop Lock-in would not only alleviate this problem but also provide better and more efficient service to students

Some critics oppose the initative because not all students ride bikes to campus and thus won't take advantage of the services offered at the Bike Shop. This theory falls apart in two key places. First, this is a broad criticism which can be thrown at each and every use of student funds; funds are directed into many projects and clubs in which, taken individually, only a minority of students participate. Yet the services provided by these funds are open to everyone with no restrictions on participation in their use. In other words, this criticism is irrelevant because it attacks the method of solving the problem and not the issue itself.

Secondly, the Lock-in will indeed benefit every student. Have you ever tried to cross a bike path between classes and seen your life flash before you as a broken down IV Cruiser careens down the path toward you? The Lock-in would provide the necessary funding for more tools and assistance to be available, generating a higher incen-

tive to fix one's bike and thus increasing bike safety.

On a final note, the Bike Shop may be forced to close its doors if this Lock-In does not pass. This would deny all students the only place around which shows us how to fix our own bikes instead of charging us to do it for us. Obviously, even the most apathetic students must acknowledge that here is our chance to make our needs as students known and listened to. Student Health Center Lock-in

Due to recent and future cutbacks in funding by the state of California, the Associated Students has decided to place on the ballot an initiative to secure funding for our campus' Health Center. The following is an opinion of the President of the Associated Students in support of the Health Center ballot initiative.

Increasing health care costs (to a tune of 8% a year), plus cost of living increases in salaries, with only a 5% increase in registration fees, our Student Health Center was forced to institute a user fee to our students. Furthermore, the equipment at every health care facility must be updated periodically to ensure the best quality service that we so often require. Because of this we ask your support of the \$12 or \$14 dollar allocation that would absorb some of the sts at our campus' Health Center. (The difference between the \$12 dollar and the \$14 dollar option is about \$100,000 dollars.

With the lean budget years plaguing the entire state over the next few years and the proposed 40% increase in fees, it is more than difficult to ask for your support of this initiative in light of such hard times. However, increased fees on a system wide level are not being raised to cover campus costs to non-academic programs. Most of the proposed increase in fees will be used to support the academic side of the university, while programs like Special Services and the Health Center that ensure the physical well-being of our students are left in the cold. The reason behind this A.S. ballo tive is to hopefully avoid a much larger problem than we currently face. With further budget cuts, staff reductions and a possible \$25 dollar user fee, this is the only way that we can guarantee quality health care for our students. An argument against this is simply: How can students lobby for lower registration fees, if they are willing to tax themselves \$14 dollars per student per quarter? The simple answer to that is; Considering that the state and the university find it necessary to preserve other programs, we as students must show the powers that be that, these programs are desired and because of the state's inability to provide for a most basic service, we must take matters into our own hands and support them ourselves.

If this A.S. Constitutional initiative does not pass a two-thirds majority vote of the students, the Health Center will be forced to take many necessary measures to generate revenue and reduce costs. Next year a \$25 dollar per student per quarter user fee will mostly likely be instituted by the Health Center unless other funds are generated. Further staff cuts, service cuts and new equipment delays will increasingly hinder the productivity and effectiveness of our Health Center. Budget cuts at the center will still take place regardless of which option you use, but the \$14 dollar option will make the blow less painful. In the coming years (if this ballot initiative fails), user fees may increase to close to (if not more than), \$50 dollars per student per quarter. And if you believe that the number of services that will quite possibly be lost, you can live without, vote no on this initiative. If on the contrary, you truly believe that this service is of value to you and your peers, then support the initiative and Vote Yes for the Student Health Center lock-in.

Associated Students President PRO Special Services Lock-in

The Special Services Program (SSP) which provides academic support services to students with temporary and permanent disabilities is clearly underfunded by the state and University. In order to guarantee that UCSB disabled students can be adequately served by SSP, the Associated Students have sponsored an initiative to continue existdisabilities. Hospitalized students receive note takers while they are unable to attend class. If a student has a hand injury and cannot write, a note taker is provided. Many temporarily injured students use on-campus transportation so they can still attend classes during their healing process. You've probably seen students on crutches, with hard casts, and leg sprains riding in the SSP black vans driving from Isla Vista to cam-

hard casts, and leg sprains riding in the SSP black vans driving from Isla Vista to campus. This is the most visible aspect of the program. Many of the temporarily disabled students have written to thank SSP after they've recovered; they say had it not been for SSP they would not have been able to complete the quarter!

Students with permanent disabilities utilize a variety of academic support. SSP arranges and provides sign language interpreters for the hearing impaired and readers for those with visual or learning disabilities. Students with mobility and other disabilities qualify for note takers, mobility support, registration assistance, special parking, test-taking accommodations, supplemental orientation, arrangements for specialized educational materials, and facilitation of access to all programs. An extensive adaptive equipment inventory is also available for students' use. All of these services make it possible for students with disabilities to successfully complete their academic careers.

Your affirmative vote will help SSP to continue existing services for temporarily and permanently disabled students on our campus. All monies generated from this election will go directly to supply services to students with disabilities. We hope you will not need our services in the future, but if you do, SSP will be there to assist you!

Special Services Program Campaign Committee

Childcare Lock-In Increase: Shall the existing \$1 per student per quarter A.S. Constitutional Lock-In Fee for the University's Children's Center be increased by \$2.00 per student per quarter to support the University's Children's Center in the continuation of affordable, quality childcare? This money will directly subsidize parent students' oblides. dents' childcare expenses.

Childcare Lock-In Fee Increase The Associated Students and the Graduate student Association are both sponsoring a measure to increase funding for the University Children's Center. The 'A.S. CHILDCARE LOCK-IN' and the 'GSA CHILDCARE REFERENDUM' if approved by students will designate \$3.000 per student, per quarter to subsidize student parents' child care tuition costs at the Children's Center. All monies raised remain on this campus and go directly to support students with young children.

The long awaited remodel of the University Children's Center will begin in June, 1991 and be completed next Fall. Families using the Center are expected to pay for the respected to prove the pay for the respected to pay for th

greatly increased child care tuition rates in order to pay for the yearly construction loan payments. Without additional support student parent tuition rates will increase by 40% to \$385 per month for a 3 to 5 year old child and over \$500 per month for an infant. Passage of the 'A.S. CHILDCARE LOCK-IN' and the 'GSA CHILDCARE REFERENDUM' will allow student parent tuitions to remain at current levels and will also allow them to receive these reduced rates for the summer months. Student parents are NOT asking for FREE child care, only affordable child care.

Currently 51% of all student children served are from minority and international families, and of the children from undergraduate students families 57% are from single parent families. Student parents are the most under-supported minority on this campus and they need your support now! The University Children's Center program must remain accessible to student families in desperate need of child care for their

A.S. Constitutional Amendments

Membership and Appointment: Do you approve of a change in the Associated Students Constitution, to be worded thusly:

ARTICLE III — LEGISLATIVE DEPARTMENT SECTION 2. MEMBERSHIP

 A)The voting members of the Legislative Council shall be elected Representatives of the Associated Students. Each Representative shall be elected be a plurality of his/her respective constituencies and shall be a resident thereof during each quarter of his/her term of office and during the quarter of candidacy for office.

SECTION 3. APPOINTMENT AND ELECTION OF REPRESENTATIVES

B)The determination of the Associated Students for the purposes of appointment shall be made by the Executive Director based upon average total as of the close of the previous fiscal year and any other relevant factors, and shall be ratified by a majority vote (50% + 1) of the Legislative Council by the first (1st) fourth (4th) regular meeting of Winter Quarter.

Publicity and Distribution of Texts: Do you approve of a change in the Associated Students Constitution, to be worded thusly:

ARTICLE IX - AMENDMENTS

SECTION 3. PUBLICITY AND DISTRIBUTION OF TEXTS

The Legislative Council shall arrange for the proper publicity which shall may include, but is not limited to, the publication and broadcast of the full text of the amendment in the student media during the week prior to the Election. Full text shall also be made available at the polls, at the A.S. Main Office and at other distribution locations.


Bill Galusha
